

**SPECIAL CALLED MEETING OF THE

Mayor Emison called the meeting to order.

Roll was called with the following Aldermen present: P.B. Conley, Jim Knox, Michael Moore and John Reddick.

Others present: Marcy Laxton, Chief Jeff Sills, Chris Davis.

Consideration of the purchase of new playground equipment was discussed. The base of the playground will be composed of natural wood chips. Scheduled delivery of the equipment will be in May 2022 with an instillation date of June 2022. Kyle East has volunteered to take down and recycle the existing equipment for the Town at no cost to us. Kyle has also agreed to sign off that he will not sell the equipment or hold the Town liable for any reasons.

After a brief discussion on the option to leave some of the old equipment intact or buy all new equipment for both parks a motion was made by Alderman Reddick to purchase all new equipment. Motion was seconded by Alderman Knox. All presented voted Aye.

First reading on Ordinance 2022-1 An order amending the Budget Ordinance 2021-1, for the fiscal year July 1, 2021 through June 30, 2022 for the purpose of replacing playground equipment. Alderman Reddick made the motion to approve, Alderman Knox seconded the motion. All Aldermen were present and voted Aye.

With no further business the meeting was adjourned.

- #2. Playworld Quote (with handwritten notation “Actual Quote #3”).


Both documents are originals and bear handwritten notations at the time of the Special Called Meeting of the Board of Mayor and Aldermen, Feb. 14, 2022. The Board unanimously approved the purchase of the playground equipment by Ordinance (first reading) upon the motion of Aldermen John Reddick, seconded by Alderman Jim Knox.


A question arose at the September 12, 2022 regular meeting as to whether the purchase of identical equipment had been authorized by the Board for both parks. These documents indicate the detail of the equipment purchases, item by item, and park by park. The only difference was the Park Street park originally had two “play units,” both of which were replaced, and the E.D. Brown park had one “play unit” that was replaced.

This memorandum is added to the Minutes of the Feb. 14, 2022 meeting in order to record more accurately the actions of the Board.
