## REGULAR MEETING OF THE MAYOR AND BOARD OF ALDERMEN MONDAY OCTOBER 7, 2019 AT 5:00 PM AT CITY HALL 97 SOUTH JOHNSON ST, ALAMO, TN 38001

Mayor Emison called the meeting to order.

Roll was called with the following Aldermen present: Larry Conder and John Reddick. Kenneth Bodkins arrived at 5:09, P.B. Conley absent.

Invocation was given by Mayor Emison.

Others present: Amanda Harris, Brad York, Ferris Arnold, Randy Camp, Cynthia Kilburn

Alderman Conder made a motion to adopt the minutes of the Regular meeting on September 9, 2019, Special Call meeting on September 5, 2019 and Emergency Meeting on September 17, 2019. Aldermen Reddick seconded the motion. All Aldermen voted, Aye.

Mayor Emison gave his monthly report on the following: 1) The paddle bearing at the Sewer Plant that originally was quoted \$20000 plus parts was done for \$2500 with the City buying the parts and having the same man as before fix it; 2) Most of the outdoor work and some electrical work has been done at the Water Plant. We should be able to finish the work and close out the grant and apply for the new one to be able to start work on the Sewer Plant in February; 3) The paving has been completed with a job well done as they did the last time; 4) A meeting was held with Suez about automatic water meters, very interesting concept yet at first glance may be cost prohibited; 5) Amanda Harris is now the Safety Coordinator; 6) Auto Zone is for sure coming to Alamo.

Alderman Bodkins stated that he would like to make sure the Safety Regulations were being used due to it being brought to his attention. This included wearing the vests and using the cones as regulated.

Mayor Emison opened the Public Hearing on the Annexation of the Hwy 54 property, Ordinance 2019-8 and Resolution 2019-7. Discussions about the intentions of the property were discussed and a motion was made to continue the consideration of the Proposed Annexation of Hwy 54 Property until January 6, 2020 by Alderman Reddick and seconded by Alderman Conder. All Aldermen voted, Aye.

Reading of Resolution 2019-8 Opposing Chicken Houses. Alderman Bodkins made the motion to adopt this resolution and Alderman Conder seconded the motion. All voted Aye.

Reading of Resolution 2019-9 Multi-Modal Grant. Alderman Bodkins made the motion to adopt and Alderman Reddick seconded the motion. All voted Aye.

Mayor Emison brought up concerns of a citizen about the traffic on Halloween night for Trick or Treaters. Chief York stated all his employees were scheduled to work that evening starting at 4 and that traffic would be directed the same as in years prior. Aldermen Bodkins made the motion to keep the same directions as last year and Alderman Conder seconded it. All voted Aye.

Mayor Emison stated the options for the employee Christmas Party. After discussion Alderman Reddick made the motion to take the money that was allotted for the party and split it among the employees in lieu of a party. Alderman Bodkins seconded the motion. All voted Aye.

With no further business Alderman Bodkins made a motion to adjourn and Alderman Conder seconded the motion. The meeting was adjourned.
